FIDDLERS ANTIQUES SHOW {referred to as FAS} reserves the right in its sole and unfettered discretion to 1) determine the eligibility of Exhibitors and exhibits for the show, 2) reject or prohibit exhibits or Exhibitors which FAS considers objectionable, disruptive or inappropriate, 3) change or modify the layout of the Show and/or relocate exhibits or Exhibitors, 4) cancel in whole or in part the Show due to an event or force majeure, 5) In the event of a cancellation due to weather or pandemic, any money paid will be refunded or applied to a future show. Exhibitor waives any rights to damages beyond the return of their deposit.

**DEALER SET UP HOURS:** all day Tuesday, February 9, 2021 from 8am-8pm.

- 1-You agree to be at and have your display open to the public during the advertised show hours.
- 2-Counterfeits, fakes or replicas of brand name items are prohibited. If counterfeit merchandise is found, you will be asked to leave the show, your booth rent will not be returned.
- 3-Confirmation of spaces will be sent prior to the event.
- 4-FAS will provide uniformed security during hours of the event to patrol the facility. However, no responsibility is assumed by the Music City Center, FAS, or the promoters and their staff. All merchandise must be removed from the building by 11pm Saturday night.
- 5- All Exhibitors must part in designated vendor parking area as per Rules.
- 6- All Exhibitors must remain set up until show closing time. NO PACKING until show closing time.
- 7- Porters are independent contractors. FAS assumes no liability for their actions.
- 8- All Exhibitors are responsible for collecting and paying Tennessee Sales Tax. 9- Deposit of \$200 required to hold space. All balances are due during check in at set-up.
